As per Order No.PT2-SDTE-HTE-HTE-I-0003/2017/3642 dated 03.08.2018 and No.3701 dated 04.08.2018 of Skill Development & Technical Education Department, Government of Odisha, Spot Counseling for the remaining vacant seats shall be conducted as per the schedule below for MBA, MCA-LE and M.Tech (CSE):

The following modalities will be followed during Spot Counseling:

1. Candidates having valid OJEE-2018 rank shall participate in counseling at college level. However, the candidates who have got final allotment in OJEE counseling process and have already taken admission in any of the technical / professional colleges of the State are not eligible to participate in Government College Spot Admission Process.
2. OJEE-2018 rules and regulations will be followed during Spot Admission.
3. All candidates seeking spot admission are required to report with the original documents and a set of self-attested photocopies as mentioned in Annexure-I (available in our website).
4. Candidates having valid rank in CAT/MAT/XAT / ATMA and CMAT are also allowed for Institute level admission in MBA program against the vacant seats as per guidelines of OJEE Counseling Brochure 2018.
5. Selected candidates have to deposit **Rs.10,000/- (Rs.5,000/-** in case of ST/SC candidates) as part admission fee and **Rs.450/-** as counseling fee through Bank Draft in favour of **Chairman, OJEE-2018, payable at Bhubaneswar**. Candidates are advised to bring 2(two) separate drafts for the above fee.
6. The guidelines / provisions on the eligibility criteria prescribed by the AICTE / other guidelines notified by the Government / OJEE counseling brochure will be strictly followed.
